ADDITIONAL INFORMATION

The City Election Commission exists to perform certain administrative duties as required by Michigan Election Law. The actions most frequently taken by the Election Commission include approving the temporary consolidation of voting precincts; appointing election inspectors (poll workers) for each election; and conducting the public accuracy test of the program and voting equipment to be used at each election.

Each person wishing to speak shall have one opportunity to address the Election Commission and may speak for up to three (3) minutes. Members of the public who are viewing the Public Accuracy Test shall observe from the designated public area.

Discussion/Action Items

Approval of Minutes

Commissioner Powers, seconded by Commissioner Robinson, moved to approve the minutes from the Election Commission meetings on July 21, October 5, and October 14, 2022. With a voice vote the motion passed.

Resolution Providing for the Establishment of Receiving Boards in the City of Kalamazoo

Commissioner Robinson noted the word “establishment” in the first paragraph of the proposed resolution and the words “whereas” in the first and second paragraph of the proposed resolution, were misspelled and should be corrected.

Commissioner Robinson, seconded by Commissioner Powers, moved to adopt, with the spelling corrections noted above, a RESOLUTION confirming and providing for the establishment of receiving boards in the City of Kalamazoo. With a voice vote the motion passed.

Appointment of Election Inspectors for the November 8th Election

Commissioner Borling reviewed the list of election inspectors for the November 8th election.

Commissioner Powers, seconded by Commissioner Robinson, moved to appoint individuals on the attached list to boards of election inspectors for the City's 27 voting precincts, the absent voter counting board, and the receiving board for the election to be held on November 8, 2022. With a voice vote the motion passed.

Establishing the Election Day Location and Hours for the Absent Voter Counting Board

Commissioner Robinson, seconded by Commissioner Powers, moved that the City of Kalamazoo's Absent Voter Counting Board conduct election day ballot processing activities on November 8, 2022 at Kalamazoo City Hall, 241 W. South Street, beginning at 7:00 a.m. local time. With a voice vote the motion passed.
